The minutes of the meeting held on 31 March 2024 were confirmed as a true record.

Verbal report from Stephen Wiltshire, Managing Director, Exeter Airport

The Committee received an update from the Managing Director, Exeter and Devon Airport Limited.

Passenger numbers for FY23 402,000. Movements were 29,727. FY24 passenger numbers were 434,639 and movements 28,000.

Summer Routes - healthy loads with no disruption, Exeter fly to 26 Destinations in nine countries with a new route to Faro (Portugal). There are currently 9 Ryanair Flights with a new Palma flight twice weekly from 02 May 2024, and Alicante 3 times a week, Faro twice weekly continuing after successful season last summer plus Malaga twice weekly.

A second based TUI aircraft will commence in Summer 25 providing an additional 80,000 seats taking passenger numbers through the 0.5 million for the first time since COVID and Flybe collapse.

FY25- 477,000 passengers FY26 – 550 – 600,000 passengers

Exeter are domestically operating (6 Routes), Belfast, Edinburgh, Newcastle, Glasgow paused at the end of March, Jersey, Guernsey, Isles of Scilly.

Royal Mail- transitioning away from air and onto road and rail by March 2025. ATR date pushed back until August, later arrival time 0310.

246 FTE (287 individuals)

Airport Carbon Accreditation – Exeter is certified at level 2 and work will continue towards level 3.

Airspace Change Proposal- stage 2 gateway rework being undertaken for resubmission

Paris, Amsterdam and Manchester- focus routes and still work in progress.
